### ORDINANCE NO. 2024- 006

# AN ORDINANCE AMENDING THE ORDINANCE ESTABLISHING CHARGES AND RATES FOR THE USE AND SERVICE OF THE COMBINED WATERWORKS AND SEWERAGE SYSTEMS OF THE VILLAGE OF YATES CITY, KNOX COUNTY, ILLINOIS.

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF YATES CITY, KNOX COUNTY, ILLINOIS:

Section 1: AMENDMENT OF SECTIONS 1 AND 6 OF THE ORDINANCE AN ORDINANCE AMENDING THE ORDINANCE ESTABLISHING CHARGES AND RATES FOR THE USE AND SERVICE OF THE COMBINED WATERWORKS AND SEWERAGE SYSTEMS OF THE VILLAGE OF YATES CITY, KNOX COUNTY, ILLINOIS.

The Ordinance Establishing Charges and Rates for the Use and Service of the Combined Waterworks and Sewerage Systems of the Village of Yates City, being Ordinance No. 2010-681, passed and approved February 10, 2010, as previously amended, is now amended so that Sections 1 and 6 shall hereafter read as follows:

Section 1: The monthly rates and charges for the use of services provided by the combined waterworks and sewerage systems for the Village of Yates City are established as follows:

#### A. Charges for Water:

For users/customers within the corporate boundaries of the Village of Yates City:

(1) First 1,000 gallons or less used (minimum charge): \$52.33

For users/customers outside the corporate boundaries of the Village of Yates City:

(1) First 1,000 gallons or less used(minimum charge): \$60.66

For users/customers within and outside corporate boundaries of the Village of Yates City:

(1) For all usage over 1,000 gallons: \$12.36 per thousand gallons.

#### B. Charges for Wastewater Service:

For the use of the services provided by the wastewater facilities of the Village of Yates City, there are established a Debt Service Charge, a Minimum Service Charge, and a Basic User Charge, as follows:

- (1) Debt Service Charge: A debt service charge of \$5.75 per month to each user/customer of the wastewater facility.
- (2) Minimum Service Charge: A minimum service charge of \$5.18 per month to each user/customer of the wastewater facility whose water consumption does not exceed 1,000 gallons per month.
- (3) Basic User Charge: A basic user charge of \$6.33 per 1,000 gallons to each user/customer for water consumption in excess of 1,000 gallons per month.

#### C. No Exemption from Wastewater Charges:

No exemption whatsoever from wastewater charges shall be allowed to any user/customer who chooses to consume a large volume of water for use in a swimming pool or other purpose metered to such user/customer.

Section 6: The Village will provide weekly residential garbage and refuse pickup and disposal services to all non-delinquent residential water account holders/customers within the corporate boundaries of the Village of Yates City pursuant to a contract between the Village and an independent contractor. The charges for such services shall be as follows:

A. Basic fee: \$14.38 per month

B. Recycling: \$1.15 per month.

C. There shall be an additional \$7.00 per month administrative fee for all non-water customers receiving garbage and refuse pickup and disposal services from the Village by agreement.

#### Section 2: CONFLICTING ORDINANCES

All ordinances and parts of ordinances in conflict herewith are hereby repealed.

#### Section 3: EFFECTIVE DATE

This ordinance shall be in full force and effect after its adoption and publication in pamphlet form, as provided by law.
