ORDINANCE NO. 2024-____

AN ORDINANCE RE-NUMBERING ORDINANCES THAT HAVE BEEN PREVIOUSLY ADOPTED BY THE VILLAGE OF YATES CITY

WHEREAS, certain Village Ordinances that have been previously adopted by the Village were inadvertently assigned an Ordinance Number that was not in compliance with the Village's ordinance numbering protocol; and

WHEREAS, Village Officials now seek to have these mis-numbered ordinances re-numbered to comply with the Village's numbering protocol and to align them with the Village's numbering system for adopted Ordinances; and

WHEREAS, the Village Board hereby further finds that it is in the best interests of the Village to amend and re-number the following previously adopted Village Ordinances as provided herein;

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF YATES CITY, KNOX COUNTY, ILLINOIS, AS FOLLOWS:

<u>Section 2</u>. <u>Section 3</u>. Nothing in this Ordinance shall revise any other provision of a previous ordinance that is identified and re-numbered herein, and each listed ordinance shall remain in effect from the respective adoption date for that ordinance.

Section 4. Any Ordinances which have been filed or recorded with the County or otherwise relied upon by a third-party based upon the original ordinance number shall remain in effect from the respective adoption date and shall not be made void or otherwise invalid by the adoption of this Ordinance.

<u>Section 5</u>. This Ordinance is hereby ordered to be published in pamphlet form by the Yates City Village Clerk, and said Clerk is ordered to keep at least three (3) copies hereof available for public inspection in the future and in accordance with the Illinois Municipal Code, while also posting a copy of this Ordinance on the Village's public notice board at the Yates City Community Center in Yates City, Illinois.

<u>Section 6</u>. All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby superseded and repealed by this Ordinance, and any conflicts shall be governed by the Ordinance.

<u>Section 7</u>. This Ordinance shall be in full force and effect from and after its passage, approval and ten (10) day period of publication in the manner provided by law.
